A new direction for public engagement

Three waves of public engagement

- 1. Communication to the public (deficit of public understanding)
- 2. Drive to develop discrete forms of public engagement (deficit of engagement)
- 3. Public engagement as diverse and systemic (deficit of responsiveness to diverse ongoing public engagements)





The rise of citizens' assemblies






- Rise of citizens' assemblies at national, local and regional levels in the UK
- Increased involvement of publics in learning about, debating, and making recommendations
- Citizens' assemblies, however well-designed, do not equate to "the views of the [UK] public"
- Interrelated with other forms of public engagement, such as activism in the form of Extinction Rebellion (XR)

"A key challenge is to not only represent individual citizens through a citizens' assembly (or other singular means), but to also ensure that the many other assemblies of citizens – such as those identified in our mapping – are represented, listened to, and allowed to act on climate change"


What are publics engaging in?
