Climate Finance

This talk examines the price of risk in climate finance. From an investment perspective, policy risk is creating an asset class that has a higher risk and return profile than policy makers may have expected and in terms of price formation for the traded products (EUAs), the risk premium in forward prices is similarly high. Some implications of this higher price of risk will be raised.
