The NSDP update 2009-2013 emphasizes that *‘to effectively deal with the implications of climate change, the capacity of RGC institutions needs to be strengthened to identify and develop a strategy to deal with the anticipated impact of the climate change, and strengthening disaster management capabilities.’*

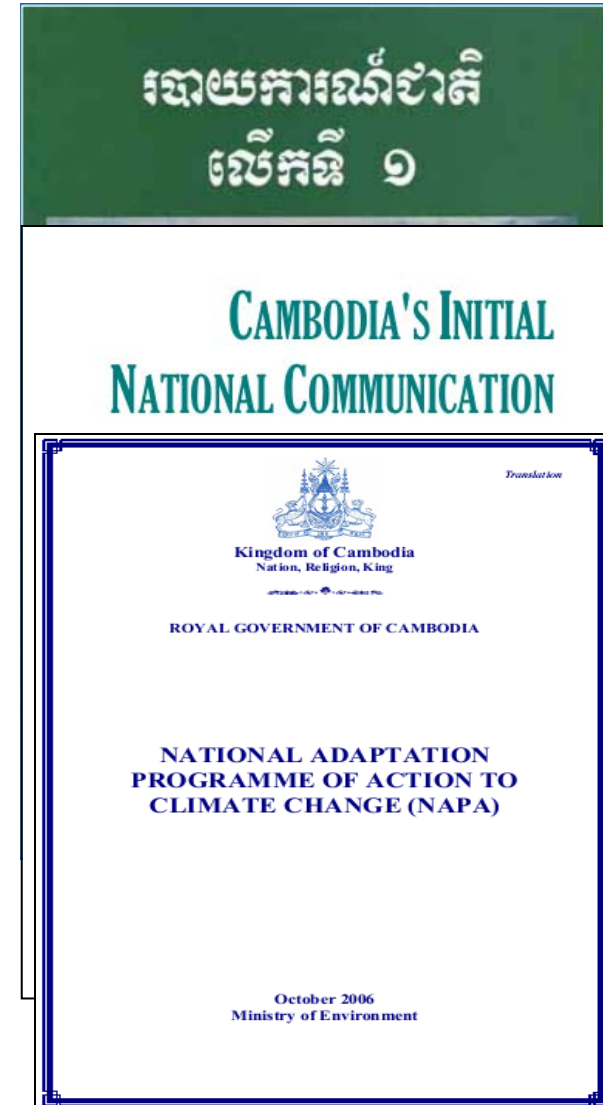

Background of the development of CCCSP (2)

- Cambodia does not have any comprehensive national level policy or strategy to address climate change (CC).
- Provides a strategic guidance on CC for adaptation and mitigation for the country
- Provides opportunity to access to global funding support that contribute the country sustainable development.



CCCSP Development Process (1)

- The development of Cambodia Climate Change Strategic Plan (CCCSP) is prioritized in National Strategic Development Plan (update 2009-2013).
- The CCCSP development format is based on advisory letter of the Council of Ministers No. 433 dated 07 Apr. 2011.

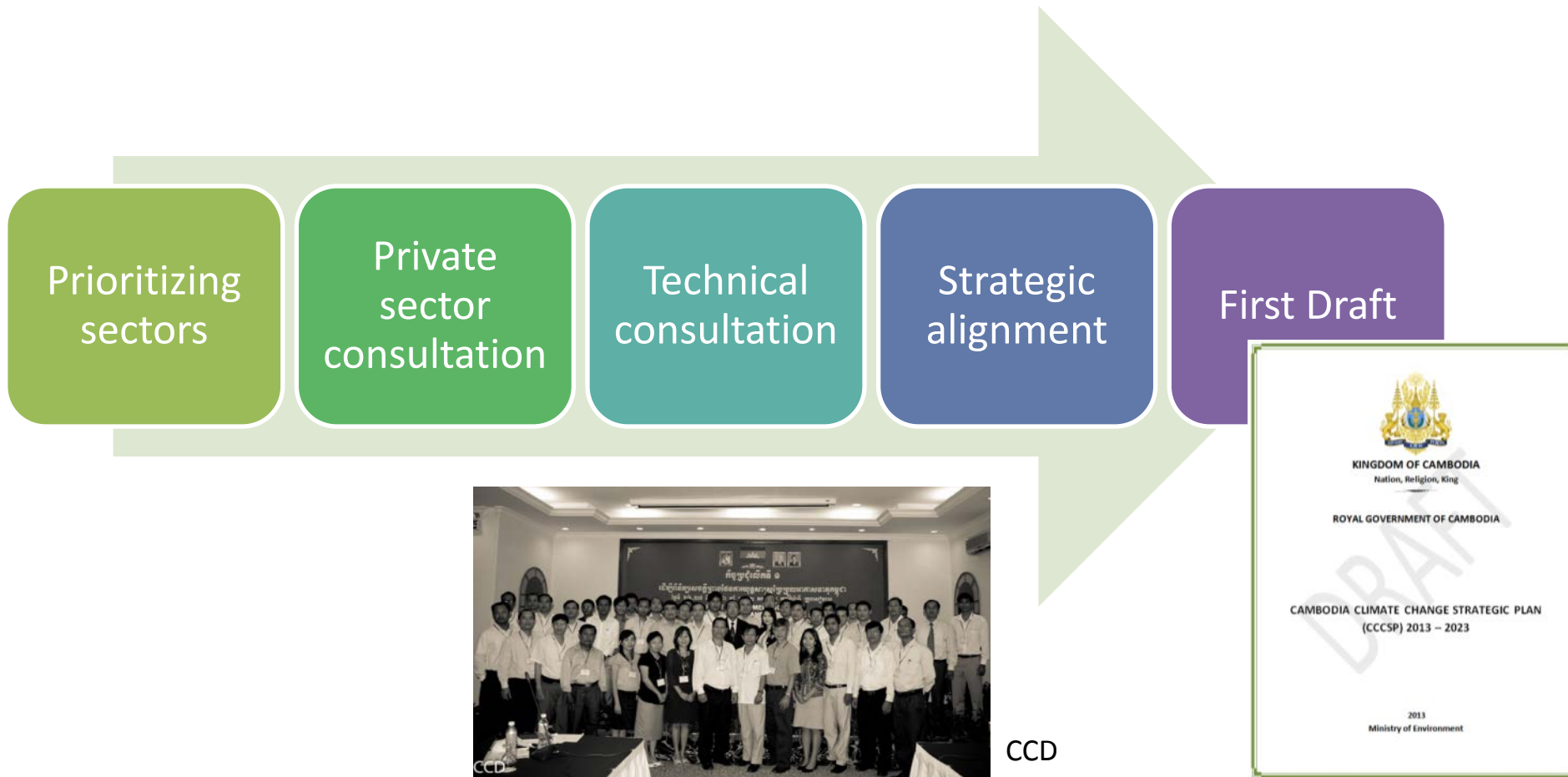

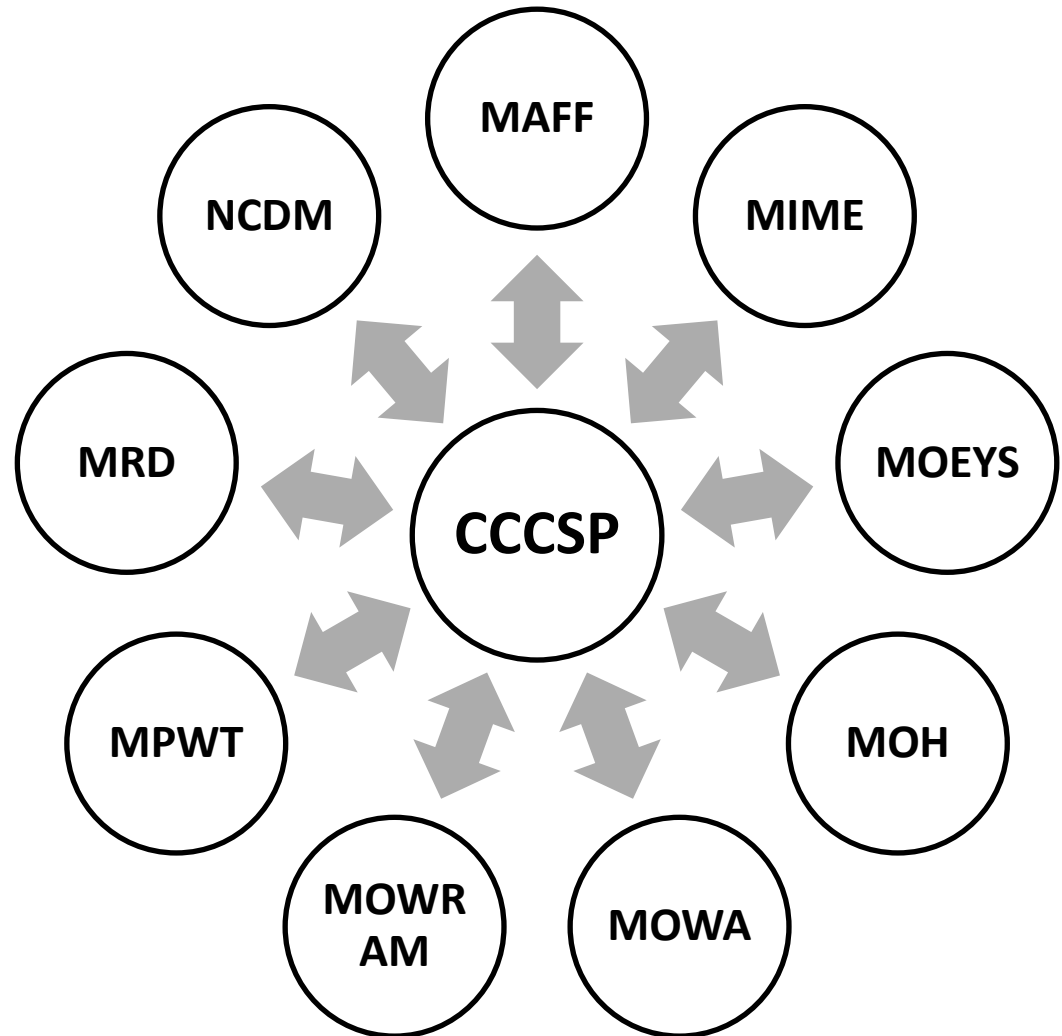

The Draft CCCSP

Vision

Cambodia develops towards a greener, climate resilient, equitable, sustainable and knowledge-based society.

MISSION

Creating a national framework for engaging public and private sectors, and civil society in a participatory process for responding to climate change to support sustainable development.

Timeframe

10 years with 5 years revision in line with the NSDP mandate

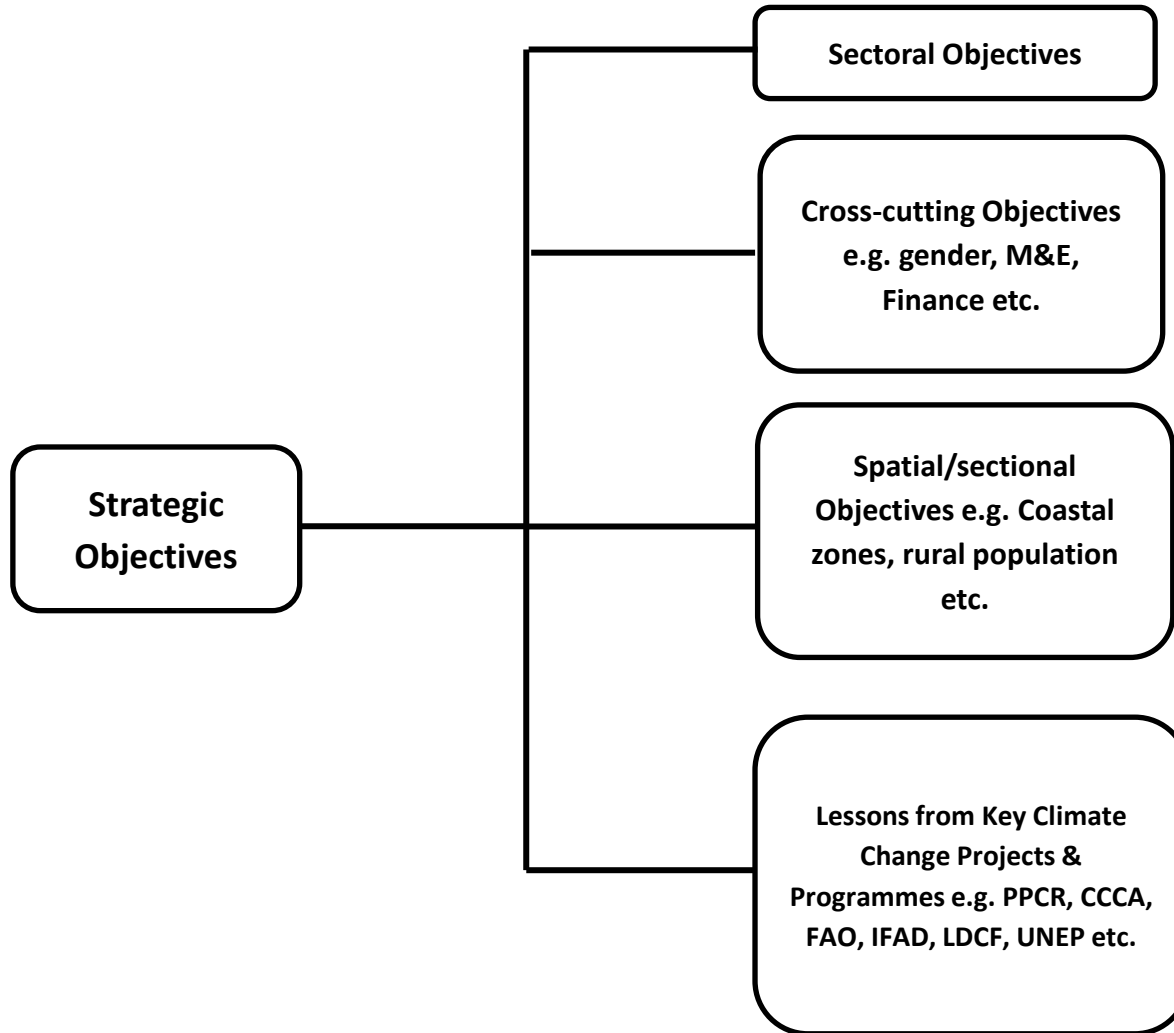

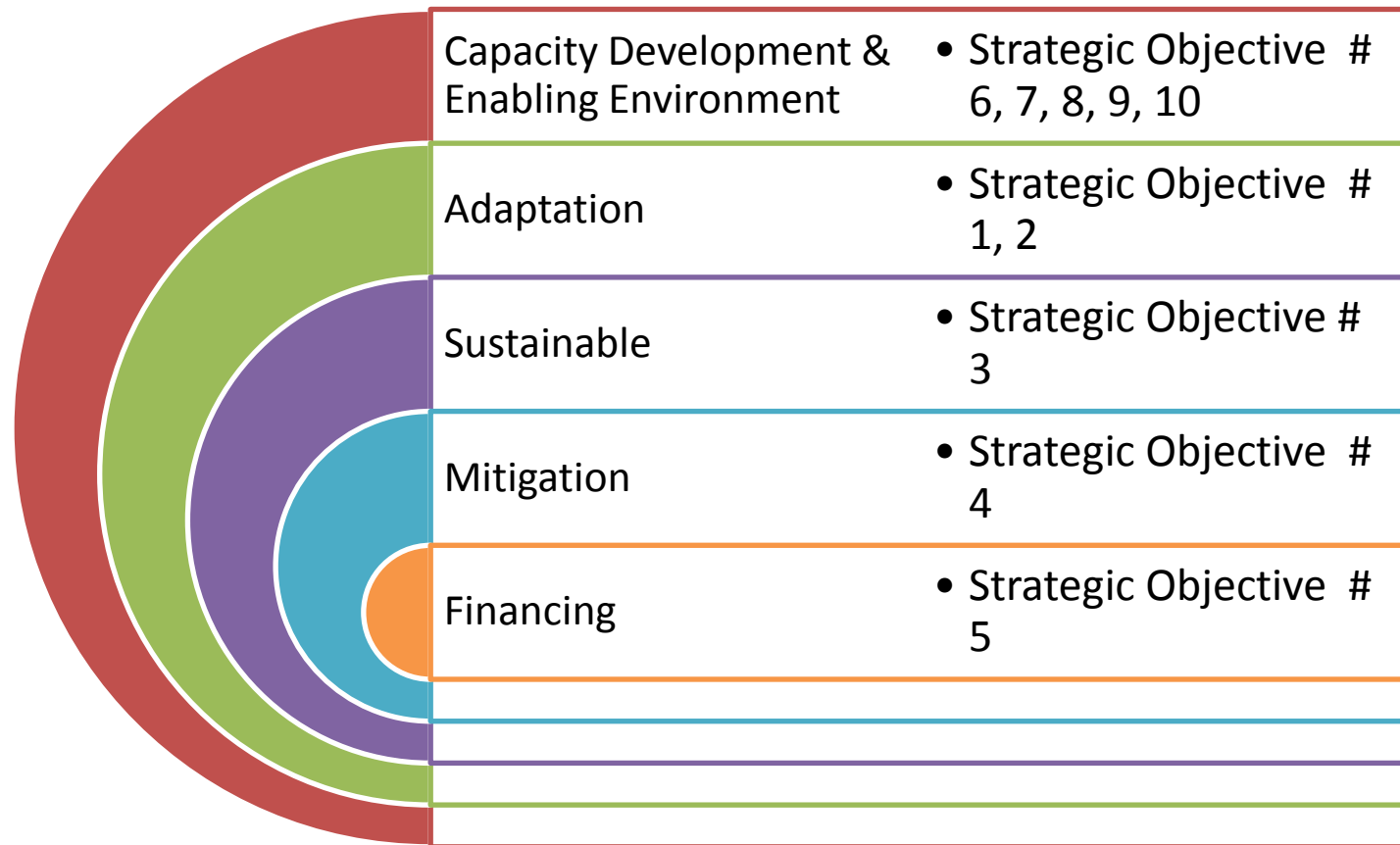

Strategic Objectives - Formulation

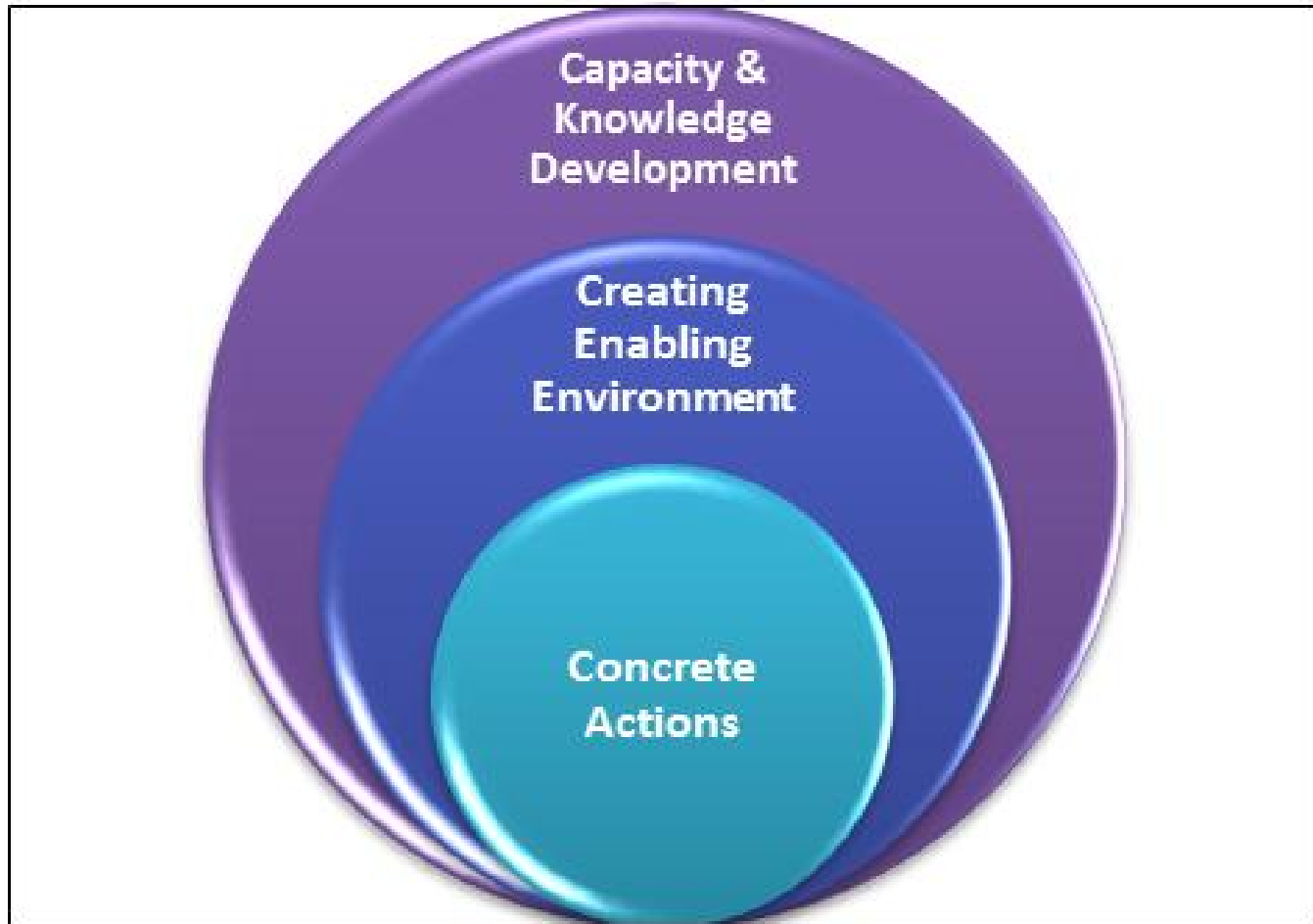


Strategic Objectives - Distribution

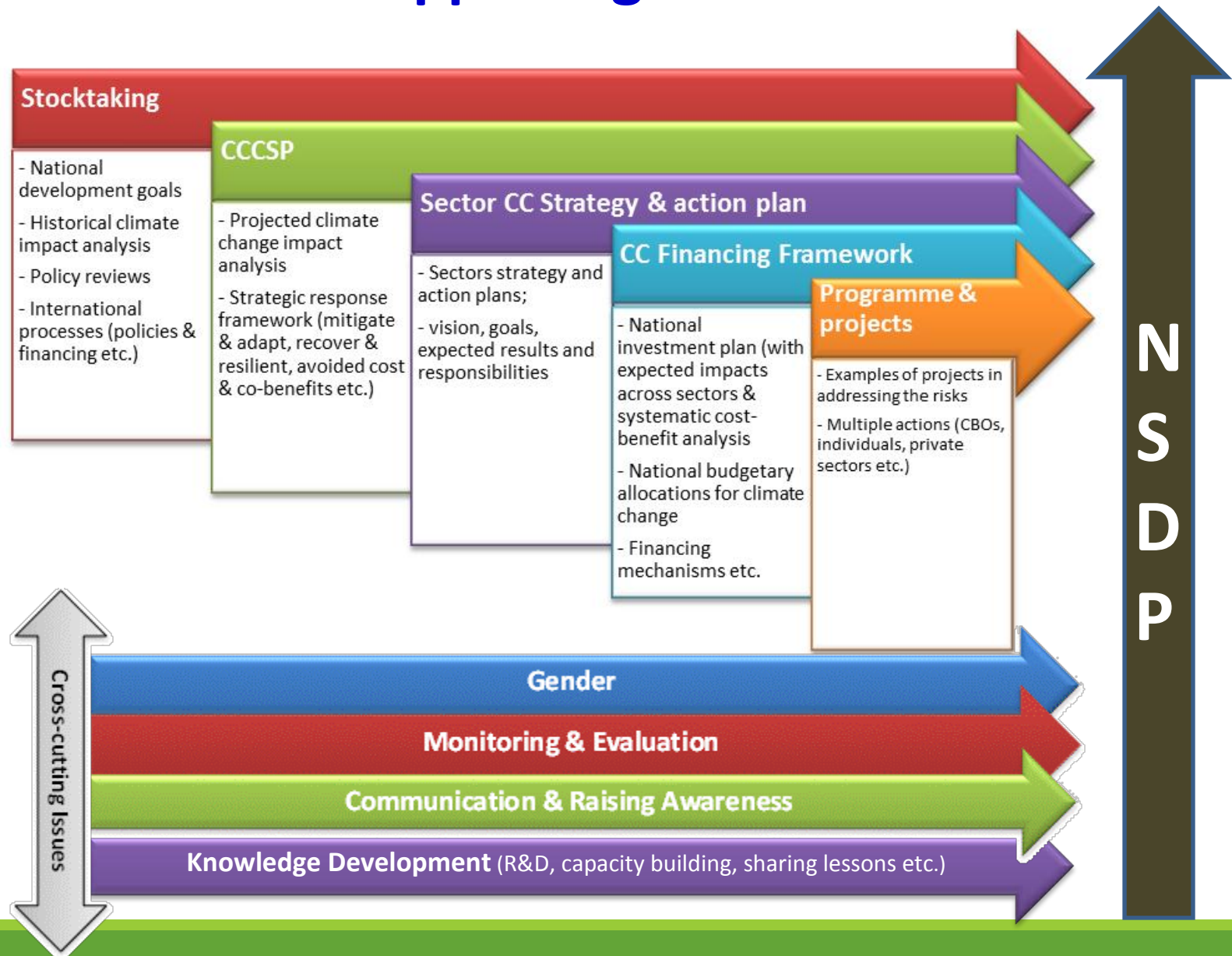
